Tender documents can be obtainable from Finance Section (Counter No. 2), Serian District Council during normal office hours **upon payment of the document fees (non-refundable) in the form of cash and tender deposit (if any) in the form of cash/ bank draft/ cheque and only to be sell to eligible tenderer.**
The tender deposit is refundable upon receipt of bona-fide tender.
3. The original / signed or certified true copy certificate of registration of contractors issued by UPKJ and CIDB Licenses, Bumiputera Status, Current Trade License and Letter of Authority shall be produced for inspection before tender document can be issued.
4. Tenders submitted must be accompanied by Photostat copies and certified true copy of the following documents: -
 - i) Business Names Registration Certificate ;
 - ii) Current Trade License **(must valid for at least three (3) months from closing date);**
 - iii) Certificate of Registration of Contractors with UPKJ **(must valid for at least three (3) months from closing date);** and
 - iv) CIDB License and Bumiputera Status **(must valid for at least three (3) months from closing date).**

If failure to do so, the Council have the right to disqualify the tender.

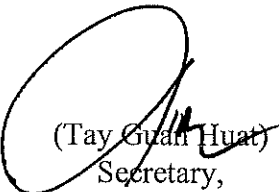
The Officer eligible to certify the documents as mentioned in Paragraph 3 and 4 is a Government Officer holding a position of Grade 9 and above, or and Officer from the Management and Professional Group.

5. The tenderer shall submit the tender in sealed envelope and marked the appropriate heading with '**CONFIDENTIAL**', the closing date, Tenders Number and also the Title of Tender on the left-hand corner of the envelope. The completed signed/ filled Tender Document shall be deposited into the Tender Box at the following address: -

6. The closing date for the tender shall be not later than **11.30 a.m. 24th October 2025 (Friday)** and any Tender's received after the specified period and time shall be automatically rejected.
